RATE OF USE

Will vary according to extent of the foam problem and also whether it is being used in an anti-foam or defoaming situation. Generally the rate will be in the range of 10-45 ml per 200 litres solution with softer water presenting a greater foam risk.

MIXING INSTRUCTIONS

Use as an Anti-foam

Always add Foam-Fighter to the spray tank before a pesticide is added as it will prevent the build up of foam.

Use for Defoaming

If foaming is already a problem in the tank add Foam-Fighter with agitation and the foam will be quickly quelled. The amount used will vary according to volume of solution, propensity of the tank components to foam, water type and agitation type/sprayer design.

NUMBER OF APPLICATIONS

Some pesticide labels specify the need of an antifoam. Use as directed on that particular label.

In other situations **Foam-Fighter** may be used as often as required for the situation.
